

**Dracut Recreation Commission
Minutes of June 13, 2016

Community Input: None.

Approval of Minutes of May 9, 2015: Motion made by Mr. McCann to approve the Minutes. Motion seconded by Mr. Talbot. Motion passed unanimously.

Review of Financial Accounts: Ms. Cahill reviewed the accounts and reminded members to note if they have outstanding Purchase Orders pending. Motion made by Mr. Scott to move \$25.19 from the Boys Winter Rec Basketball account to the Adult Basketball account to zero it out. Motion seconded by Mr. Desmarais. Motion passed unanimously. Ms. Cahill noted that we may have to cancel the Swim Program due to lack of registrations and if that is the case we would refund those individuals who signed up. Mr. Talbot noted that the Ski Program had a credit this year and Ms. Cahill explained there were some price differences with the mountain and the Dracut Appreciation Night. Motion made by Mr. McCann to approve the Financials. Motion seconded by Mr. Scott. Motion passed unanimously.

Committee Reports:

- **Boys Basketball:** Mr. Scott stated he purchased a lot of equipment/supplies which is being stored in the basement at Town Hall. They had sign-ups for Basketball and the numbers were relatively close to what they are this year except for the Clinic-1 Program which is down about 8 registrations. Due to that they will only have 6 per team instead of the usual 8. Teams have been made. Schedules have been posted. This is for boys only, not the girl's teams.

- **Baseball:** Mr. McCann informed the board that all is good. He recently met with Lori Cahill about getting some work done at two Veterans fields which will be paid for from their fundraising efforts. They are going to fix the mounds, square the fields up. The Town has approved these repairs. The Recreation season ends on Monday, June 20, 2016 and the Travel season starts up right after that. W.J. Smallwood is doing the field work. They have a crew that does only athletic fields. They will be widening the base paths, fix mound positions, repair exposed concrete.

Old Business: Mr. Malonis inquired about the new bathrooms at the Monahan Field. Ms. Cahill explained they hope to have final pavement in another week. Have been waiting for the parking lot to be striped in order to get Occupancy Permit. Ms. Cahill mentioned the skateboard park. It has been open since Memorial Day weekend. Have had very few skaters and have been rained out a couple of times. We currently have full coverage, 7 days a week, 7 hours a day. If the usage numbers don't increase Ms. Cahill will revisit.

Motion made by Mr. McCann to adjourn the meeting. Motion seconded by Mr. Talbot. Motion passed unanimously.


