

BOARD OF SELECTMEN – MEETING OF JUNE 3, 2013  
PARENT ROOM, LAKEVIEW JUNIOR HIGH SCHOOL

PRESENT – Cathy Richardson, Chairperson, Joseph DiRocco, Jr., Vice Chairman, Robert O. Cox, Clerk, John J. Zimini, Tony Archinski, Dennis E. Piendak, Town Manager, Glen Edwards, Assistant Manager/Planner and Shannon Rowe Beaulieu, Recording Secretary.

TIME – The Chairman called the meeting to order at 6:21 p.m.

Ms. Richardson stated that this meeting of the Board was to review the Warrant Articles that were tabled to tonight's Town Meeting.

Article #16 – Mr. Piendak read Article #16 and stated that there is a \$1.3 million dollar increase in the bidding process. Mr. Piendak stated that there is a \$17,000 difference between the first and second bidder. Mr. Piendak discussed the alternate numbers for slate flooring, landscaping, etc. Mr. Piendak stated that he recommends approval of this Article. Mr. Piendak stated that all work for the New Town Hall will be completed within the \$9.3 million dollar budget at 3% borrowed.

Motion made by Mr. Zimini to approve Warrant Article #16. Motion seconded by Mr. Cox. Motion passed unanimously.

Article #36 – Mr. Leo Gaudette, Town Moderator, appeared before the Selectmen and advised the Board that Article #36 does not fall under the purview of Town Meeting. Mr. Gaudette explained that the petitioner can only ask that the Selectmen place the information on the Board of Selectmen's meeting agenda for discussion. Mr. Gaudette explained that the Town Meeting body can not tell the Board of Selectmen what to do. Mr. Gaudette recommended dismissal of this Article.

Motion made by Mr. Zimini to recommend dismissal of Warrant Article #36. Motion seconded by Mr. DiRocco. Under Discussion:

Mr. Rich Cowan, the voter petitioner, discussed amending the Warrant Article and asked that the Finance Committee review the amendment. Mr. Cowan read his proposed amended Warrant Article. Mr. Cowan stated that he felt as though Town Meeting was the appropriate forum.

Mr. Gaudette reviewed Mr. Cowan's proposed amended Warrant Article and stated that the topic is still the same.

Motion passed unanimously.

Article #37 – Mr. Leo Gaudette, Town Moderator, reviewed Warrant Article #37 and stated that they can't have the Legislative Body rescind legal actions.

Motion made by Mr. Zimini to recommended dismissal of Warrant Article #37. Motion seconded by Mr. DiRocco. Motion passed unanimously.

ADJOURNMENT

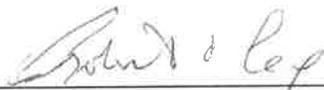
Motion made by Mr. Zimini to adjourn the meeting. Motion seconded by Mr. Archinski. Motion passed unanimously.

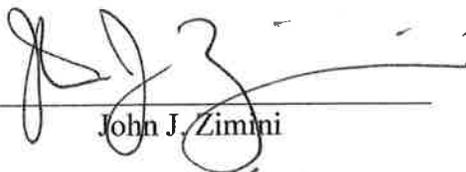

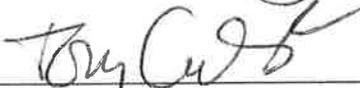
