Attached you will find the School Department's FY24 Capital Plan submission as approved by the School Committee on January 9, 2023. A few notes:

1. The total request for the school department is \$22,848,400.
2. As you will see, the Greenmont Avenue Elementary School is at the top of the priority list. As has occurred in past years, when a Statement of Interest to the MSBA is anticipated, that project/s is listed as the highest priority. We are preparing such a SOI for action by the School Committee and Selectmen. Parenthetically, I have also informed the MSBA that in regards to the Campbell project, we are still open to some form of consolidation with the Greenmont.
3. You will see a large HVAC project for the Richardson Middle School (\$5,400,000). It is currently anticipated that I will be using ESSER III funds to cover a portion of the cost of this project. Additionally, we are preparing to submit a competitive grant to the Federal Government to cover the remaining costs less a 5% town matching requirement as recently discussed.
4. There are six (6) projects listed for the Brookside Elementary School. Note that given the MSBA has suspended its Accelerated program, once the Campbell project is cemented with a definitive plan, it is the intention of the school department to begin submitting SOI's for the Brookside to the MSBA via its Core program process.

There are a number of other items on the school department's submission that I am happy to discuss in more details. I look forward to a future Capital Plan Committee meeting to provide those details.
