The Annual Town Meeting for the Town of Dracut was held on Monday, June 2, 2025, at the Lester G. Richardson Center for the Performing Arts, Dracut High School, 1540 Lakeview Ave., Dracut, Massachusetts.

The meeting was called to order at 8:30 PM, with a quorum certified by the Town Clerk.

Nichole Rosado, Valedictorian of Dracut High School Graduating Class of 2025, read the following Tercentennial Proclamation into the minutes:

In accordance with the provision set forth in Article #2 of the June 3rd, 2002 Annual Town Meeting, I hereby publicly proclaim that the time capsule buried on April 28th in the year 2002 at the Tercentennial Park, shown on the Assessors' Map 50 as Lot 202, 1310 Bridge Street, Dracut, Massachusetts, shall be opened and all items therein placed be displayed at a public ceremony to be held in the year Two Thousand One Hundred One (2101), and further that this proclamation will continue to be made each and every year at the Annual Town Meeting, and within the Annual Town Report for the next 76 years.

Moderator Brian M. Flaherty presented the following declaration marking the 250th anniversary of the Battle of Lexington and Concord:

It was around 2:00 in the morning, on Wednesday, April 19, 1775, when Capt. John Trull of Tewksbury fired three shots across the Merrimack River into Dracut. These shots were signals to Capt. Joseph Bradley Varnum of Dracut, warning him and the Dracut Minutemen who had been training for this very moment that “the Regulars were coming” for a weapons stash, 20 miles away in Concord.

Word quickly spread throughout Dracut that night and a collection of Dracut men - some rich, some poor, some young, some old - came together as one people and made the long 6 hour march towards Concord. They did not arrive in Concord until noon and missed the fighting at the Lexington town green and the Old North Bridge. But the Dracut men were a part of the march following the British soldiers back to Boston and many of those men took part in the ensuing siege of Boston. Two months later, three Dracut men would die at the Battle of Bunker Hill.

Dracut’s population at the time was 1,173 and of those, 439 men would fight in the Revolutionary War. These 439 sons of Dracut represented 39% of the town’s population. No other city or town in the 13 colonies could claim a high participation rate of its residents – not Boston, not Philadelphia, not Charleston, no one.

This spring, Town meetings across our commonwealth are marking this 250th anniversary of the start of the Revolutionary War. Town Meeting is a fitting venue to honor and remember those who fought to preserve the very thing we are doing tonight – self-government. Town Meeting form of government in Massachusetts dates back to 1680 and is the purest form of democracy in our commonwealth, if not the world. And quite frankly, we almost lost it as Town Meetings and local government control had been suspended by the British Parliament in the aftermath of the Boston Tea Party.

Those 439 Dracut men put aside any differences they may have had and came together for a common cause. They did so because they loved their freedom, they loved their town, they loved their colony, and, undoubtedly, they loved one another. We thank these men for helping to preserve Town Meeting and let us honor their sacrifices tonight through our respectful and civil discussions, reminding the world that democracy, Greek for “people power”, is still the greatest form of government designed by man.

The composition of the Committee, the appointing authority and the terms of office for the Committee Members shall be:

EXISTING LANGUAGE:

A. Membership

- (1) One member of the Conservation Commission established under Section 8C of Chapter 40 as designated by the Commission;
- (2) One member of the Recreation Commission established under Section 2 of Chapter 45 as designated by the Commission;
- (3) One member of the Historical Commission established under Section 8D of Chapter 40 as designated by the Commission;
- (4) One member of the Planning Board established under Section 81A of Chapter 41 as designated by the Board;
- (5) One member of the Housing Authority established under Section 3 of Chapter 121B as designated by the Authority;
- (6) Four members appointed by the Board of Selectmen, all of whom must be Town Residents
